IDENTIFICATION OF 2013A PROGRAM SECURITIES

In the Official Statement, dated January 9, 2013 (the "Official Statement"), relating to the above-described Bonds (the "Series Bonds"), the Minnesota Housing Finance Agency (the "Agency") agreed on page 4 under the heading "Introduction" to submit to the Electronic Municipal Market Access repository of the Municipal Securities Rulemaking Board a document identifying the 2013A Program Securities by CUSIP number, pool number, pass-through rate and outstanding principal amount no later than two Business Days after the date of issuance of the Series Bonds. Terms used with initial capital letters but not defined herein have the meanings given them in the Official Statement.

The Series Bonds were issued on February 28, 2013. Attached hereto as Exhibit A is a description of the 2013A Program Securities, identified by CUSIP number, pool number, pass-through rate and outstanding principal amount. No more than 35% of the aggregate outstanding principal amount of 2013A Program Securities are Fannie Mae Securities and all principal of and interest on the 2013A Program Securities are allocated to the Series Bonds.

Certain 2013A Program Securities have been purchased on a blended basis with other sources of funds of the Agency in order to satisfy mortgage yield limitations under the Code. With respect to such participations, principal repayments and prepayments will be allocated on a proportionate basis to each funding source and interest payments will be allocated in their entirety to the Series Bonds. The 2013A Program Securities representing participation interests in Program Securities are specifically identified in Exhibit A.

This information is provided by the Agency voluntarily and is not required to be disclosed by the Agency under its Continuing Disclosure Undertaking. The Agency is not obligated to update this information, except as may be required under the Continuing Disclosure Undertaking. Nothing contained herein is, or should be construed as, a representation by the Agency that this information constitutes all of the information that may be material to a decision to invest in, hold or dispose of any of the Series Bonds.
