

2017 LEGISLATIVE SESSION

Affordable Housing Funding Summary

The Legislature met beginning in January, working with a \$1.6 billion surplus, to enact a two-year, \$46 billion budget. The Legislature also worked on capital investment, transportation and tax bills, none of which were enacted in the 2016 Legislative Session.


The 2017 Regular Session ended on May 22 without final agreement on all of the major spending bills, capital investment, transportation or a tax bill. The Legislature immediately convened in a Special Session to complete its work. Minnesota Housing's budget passed during the Regular Session as part of the Omnibus Jobs and Energy Bill.

Omnibus Jobs and Energy Bill (2017 Regular Session, Chapter 94) Minnesota Housing Budget (Article 1, Section 3)

The bill provides \$107,596,000 in total spending for Minnesota Housing programs, which includes one-time initiatives as well as a new base program for workforce housing development.

The budget includes \$2 million in one-time funding for **Homework Starts With Home**, which is an initiative to provide rental assistance to families with school-aged children that are homeless or highly mobile. This initiative builds on the success of the Rental Assistance for Highly Mobile Families pilot funded in the previous two budgets by the Legislature.

The bill moves the **Workforce Housing Development Program** from the Department of Employment and Economic Development (DEED)



to Minnesota Housing. The program received \$4 million in base funding for FY2018-19. Funding for this program will be awarded outside of the agency's consolidated Request for Proposal (RFP) process in a separate RFP process. We will work closely with DEED to gain a good understanding of how the program has been run over the past two years.

Capital Investment Bill (2017 Special Session, Chapter 8)

The Capital Investment bill was the final bill passed during the special session that ended on May 26. The bill authorizes Minnesota Housing to issue \$35 million in Housing Infrastructure Bonds. The bill also allows Minnesota Housing to issue up to \$20 million in Housing Infrastructure Bonds using existing debt service appropriations from the 2014 and 2015 bonding authorizations.

The bill authorizes \$10 million in General Obligation bonds for public housing rehabilitation, which will be used to fund the Publicly Owned Housing Program (POHP).
