Our Unique Role



- New resources for local governments and regions
- State invested in local government support
- New resources for new programs include over \$100 million in annual sales taxes in the metro and over \$50 million in annual appropriations all targeted to units of local government.

- January 2025: Local Housing Trust Fund Program Intent to Apply & Request for Proposal (RFP) Launch
- March 2025: Local Housing Trust Fund RFP Application Due

Local and Statewide Housing Aid Greater Minnesota Small Cities (Tier II Cities) Housing Aid Grant Program

Local Affordable Housing Aid (LAHA)

LAHA helps Twin Cities metropolitan local governments meet local housing needs through affordable housing development projects and support for organizations and individuals in maintaining stable, affordable housing

- All seven Twin Cities metropolitan counties and metropolitan cities with over 10,000 residents
- Dedicated sales tax of \$0.0025
 - 25% to cities
 - 50% to counties
 - 25% to rental assistance
- Dept. of Revenue sends funds directly
- First disbursements: July 2024
- Next disbursements: December 2024
 - 2x/year in 2025 and beyond

Statewide Local Housing Aid (SAHA)

Similar to LAHA, SAHA helps Tribes and Greater Minnesota counties and cities meet local housing needs through affordable housing development projects and support organizations and individuals in maintaining stable, affordable housing.

- All 87 Minnesota counties, nonmetro cities with over 10,000 residents and all 11 Tribal Nations
- \$22.5M appropriation for 2023 and 2024, appropriation steps down starting in 2025
- Department of Revenue administers
 - Share of funds to MN Housing for Tier II cities
- Minnesota Housing supports the program and collects reports
- First round of funding disbursed in late 2023
- Additional disbursements in July and Dec. 2024
 - 2x/year in 2025 and beyond

Role of Minnesota Housing for LAHA/SAHA

Role of Minnesota Housing:

- Collects reporting (starting in 2025)
- Support local governments (e.g., FAQ)
- Assist in coordination between housing programs and partners
- Administers Tier II grants

Use of Funds:

- Funds must be spent on a qualifying project.
- Must prioritize affordable housing for lowincome households (at or below 80% AMI for homeownership, 50% for rental).





LAHA/SAHA Requirements

Qualifying Projects:

- Emergency rental assistance
- Financial support to non-profit affordable housing providers
- Construction, acquisition, rehabilitation, demolition or removal of existing structures, construction financing, permanent financing, interest rate reduction, refinancing to provide affordable housing to those who earn less than 115% of AMI (homeownership) and 80% AMI (rental)
- Financing the operations and management of financially distressed residential properties (2024)
- Funding of supportive housing (2024)
- Costs of operating emergency shelter facilities, including services (2024)
- In limited cases, development of market rate residential rental property in Greater MN (SAHA only)

Deadlines & Local Housing Trust Funds

Aid Funds Disbursed in 2023:

- Must be committed to qualifying project(s) by Dec. 31, 2026.
- Must be expended by Dec. 31, 2027.

Aid Funds Disbursed in 2024:

- Must be committed to qualifying project(s) by Dec. 31, 2027.
- Must be expended by Dec. 31, 2028.

Limited Potential to Surpass Deadlines:

- Tier I cities and counties may be able to surpass a deadline if:
 - Necessary due to factors outside the aid recipient's control;
 - Demonstration accepted by Minnesota Housing;
 - Funds placed in a local housing trust fund.
- Not a "parking lot."
- Not available for Aid Funds to Tier II Cities or Tribal Nations.



Annual Reporting Starting in 2025

Coming 2025: Greater Minnesota Tier II Cities Housing Aid Grants

- Greater Minnesota cities with populations below 10,000.
- Same general uses as SAHA.
 - Program Guide due out later this week.
- Competitive grant process, prioritizing based on proportion of cost-burdened households.
- Expect most awards in the range of \$100,000-\$300,000.



Up to \$4.5 million Two years of appropriations in one RFP

Greater Minnesota Housing Infrastructure Grants

Coming 2025: Greater Minnesota Housing Infrastructure Grants

- Up to 50 percent of the capital costs of public infrastructure necessary for an eligible workforce housing development project.
- Grants limited to: \$40,000 per lot for 1-4 units \$180,000 per lot for multifamily (5+ units/building) \$60,000 per manufactured housing lot
- Cities and counties limited to \$500,000 over a twoyear period; no maximum for manufactured housing
- Single family, multifamily, and manufactured housing projects are eligible.

Local Housing Trust Fund Grants Program

Coming 2025: Local Housing Trust Fund Grants

- Incentivize local governments to create or fund Local Housing Trust Funds
- Program uses state funding to match a portion of New Public Revenue to encourage investment in affordable housing across Minnesota
- Matching funds awarded up to 100% of New Public Revenue, up to \$150,000
 - Additional funds may be available to match 50% of new public revenue between \$150,000 and \$300,000
 - New Public Revenue defined as local funds committed **on or after June 29, 2021**.
