## 2021 Legislative Outcomes

#### Increased investments in existing programs

- \$12 million for Emergency Services Program and additional \$2 million increase for emergency shelter to increase capacity and improve conditions
- \$26 million for Community Living Infrastructure grants
- Expanded funding and activities for Housing Stabilization Services
- \$583,0000 for Emergency Assistance for Postsecondary Students program
- \$6.3 million for supporting and expanding Veteran homelessness efforts
- \$100 million investment in Housing Infrastructure Bonds

#### New programs or initiatives

- Reentry supports and plan to mitigate homelessness in corrections involved individuals
- Task Force on Shelter
- \$40 million in Local Homelessness Prevention Aid (starting SFY 2024)

### **Local Homeless Prevention Aid**

- Aid to county governments distributed by Minnesota Department of Revenue
- Amount per county calculated based on:
  - Share of state population
  - Rate of student homelessness
  - Minimum of \$5,000 per county
- \$20 million per year, paid in two installments
  - Initial county allocations will be determined by August 1, 2022.
  - First installment (\$10 million total) in December 2022. Next installment June 2023.
  - Five years of payments ending with FY2028.

- Legislative intent and justification based on Homework Starts with Home.
- Legislative purpose is "to help local governments ensure no child is homeless within a local jurisdiction by keeping families from losing housing and helping those experiencing homelessness find housing."
- Funds can go to a wide variety of new or existing projects or programs.
- Counties must report on use of funds.
- Significant local discretion in use of funds.
- Full legislative details: Minnesota Session Laws 2021, 1<sup>st</sup> Special Session, Chapter 14, Article 7, Section 3.

## Potential activities and next steps

Funded activities may be administered by a county, a group of contiguous counties jointly acting together, a city, a group of contiguous cities jointly acting together, a Tribe, a group of Tribes, or a community-based nonprofit organization.

#### Funded activities must include plans for:

- Targeting homeless or at-risk families with PreK 12 children
- Targeting unaccompanied youth in need of an alternative residential setting
- Connecting families with the social services necessary to maintain the families' stability in their homes
- Providing one or more of the following:
  - Rental assistance
  - Support and case management services to improve housing stability

#### **Next steps**

- Interagency team consisting of Minnesota Housing, MDE, and MICH is compiling examples, templates, and best practices to share with interested counties and other partners.
- Supporting existing programs (FHPAP, HSWH, etc.) will be included.
- Hopefully will include peer-to-peer learning and support opportunities

Homelessness is the most egregious form of housing injustice.



- The Walz-Flanagan Budget to Move Minnesota Forward prioritizes investments in housing Stability budget. This includes:
  - 35 proposals from six State agencies
  - 19 new programs and budget line items
  - Over \$1 billion in proposed spending over the next three State fiscal years
