**Fair Housing Policy**

The applicant certifies that all requirements under Minnesota Housing's [Fair Housing Policy](#) are met.

**Eligible Infrastructure Redevelopment and Improvements**

The applicant certifies that the application being submitted is to obtain funds to be used for eligible infrastructure redevelopment and improvements to a manufactured housing park or acquisition of a manufactured home park.

Eligible infrastructure and improvements include water and sewer installation and improvements, installment or repair of storm shelters, electrical system installation and repairs, road and sidewalk installation or improvements, necessary installation or repair of park signage, installation or repair of security systems and fences, and park lighting installation or repair, as well as acquisition of manufactured home parks and improvements required for acquisition of a manufactured home park. Other infrastructure improvements may be eligible as approved in writing by Minnesota Housing.

**Environmental Issues**

The applicant certifies that any known environmental issues, and any issues discovered during project construction, will be mitigated in accordance to all local, state and federal laws.

**Building Standards**

The applicant certifies that the developer, architect, general contractor and all other parties will adhere to the local building code. If a project does not have a local building code, the applicant certifies that all parties will adhere to the state of Minnesota building code.

**Compliance with Local, State and Federal Laws**

The applicant certifies that the project will be completed in accordance with all local, state and federal laws, as well as applicable Minnesota Housing policies.

**Eligible Parks**

The applicant certifies that the funds received through the Manufactured Home Community Redevelopment Program will be used for infrastructure redevelopment or acquisition of an eligible manufactured home park that meets the criteria as defined in the application description.

**Certifications**

**Informed Consent to Share Data**
